Contribute to Students First Foundation and get the Arizona Individual Tuition Tax Credit, a dollar-for-dollar tax credit



The Arizona Individual Tuition Tax Credit

Program was established in 1997 to allow Arizona taxpayers a way to redirect their tax dollars toward giving Arizona's children a choice in their education.

Why Should I Give?

This is your opportunity to decide what your AZ tax dollars will be used for. You can help a worthy student by utilizing the Tuition Tax Credit Program through Students First Foundation. When you give, you receive a dollar for dollar credit on your Arizona taxes. Your donation will support families seeking quality education for their children.

Who Can Give?

Any Arizona taxpayer may give to support this program with a redirection of the tax dollars paid to The State of Arizona. You can give any time throughout the year; either in several payments or in one lump sum.

Tuition Tax Credit • Original

Arizona tax law allows individual taxpayers an income tax credit up to \$623 (single filer and head of household) or \$1,245 (married filing jointly) for donations to a school tuition organization, such as Students First Foundation under the Original Individual Income Tax Credit.

Tuition Tax Credit • PLUS

The PLUS tax credit provides a scholarship opportunity for children who have had difficulty accessing a tax-credit scholarship. For that reason, existing scholarship recipients are not eligible for a PLUS scholarship.

Who is eligible for the PLUS program?

Eligible children include those who:

1. Attended public school for 90 days of the prior fiscal year and transferred to a qualified school:

- Governmental primary or secondary school (K-12)
- Governmental preschool program for students with disabilities

2. Enrolled in a qualified school in Kindergarten or a Preschool program for students with disabilities.

3. Is the dependent of a member of the US Armed Forces who is stationed in Arizona pursuant to military orders. The 90 day public school requirement is waived.

4. Received a scholarship under the 1, 2, 3, low income credit, or the disabled/displaced credit and continued to attend a qualified school.

Contribution Amounts

- Contribution limits for Original: \$623 per single filer or \$1,245 for married filing jointly
- Contribution limits for PLUS: \$620 per single filer or \$1,238 for married filing jointly
- You may donate to the PLUS TAX after donating the maximum for the Original
- There are annual limits set by the state of Arizona. For the **2022 tax year**, here are the Annual Private Tuition Tax Credit Maximums:

SINGLE: \$1,243 (\$623 ORIGINAL + \$620 PLUS MARRIED: \$2,483 (\$1,245 ORIGINAL + \$1,238 PLUS)

Donors may recommend a private school of choice, or a student that fits the criteria listed in "Who is Eligible". See the next page for recommendation options.
